Minutes for: May 18, 2022

#### MINUTES FO THE PREVIOUS MEETING:

The minutes of the April 20, 2022 meeting were approved on a motion by A. Winzinger and seconded by T. Budd. Abstention D. O'Connell. All in favor.

#### **FINANCIAL:**

- The next CD maturity is 8/6/22 at Republic Bank (13 mo. @ .6%).
- Current rates at Republic are: 6-11 mo. @ .15%, 12 mo. @ .25% and 13-23 mo. @ .35%.
- William Penn Bank is offering a 15 month special at .75%. The Board has agreed to transfer \$147,000.00 to William Penn at the .75% rate for the 15-month period.
- D. Caldwell will arrange for R. Reitmeyer to discuss available CDs with a representative of TD Bank.

The Bills to be paid for May were reviewed and accepted on a motion by D. O'Connell and seconded by T. Budd. All in favor.

### **CORRESPONDENCE: R. Reitmeyer**

- State of New Jersey Executive Department has issued a Proclamation of Soil and Water Stewardship week for the district from April 24<sup>th</sup> May 1, 2022.
- Email from F. Minch regarding the Supervisor Performance Standards requesting any comments to be submitted by May 31, 2022 to his attention.
- Email from Rutgers New Jersey Agricultural Experiment Station announcing a Green Stormwater Management Online Course being held on June 14<sup>th</sup> and June 15<sup>th</sup> at a cost of \$325.00. The Board has agreed to allow T. Robinson to take the course.

#### STAFF REPORT: R. Reitmeyer

- Reitmeyer identified that he has been working to complete as many basin inspections as possible prior to increased spring vegetation.
- Droughty conditions have resulted in an increased need to require the implementation of dust control measures. This is especially true on some of the larger sites that are now active.

#### NRCS REPORT: Tairi Colon

- **1.** \$2.3MM were added to NJ to fund the EQIP program. This permits several more applications in Columbus to be funded.
- **2.** A newly hired Quail Biologist partner employee Abigail McBride has started. She will cover all of south Jersey and her office is in Columbus.
- **3.** There will be a Civil Rights Review of NJ in June. NRCS will ask T. Budd to be interviewed as part of the review for Columbus.
- **4.** We have several plans for BSCD certification, all are for EQIP contracts
