- R. Reitmeyer indicated that no CDs will be maturing prior to the June District meeting.
- Bills to be paid for May were reviewed and accepted on a motion by A. Winzinger and seconded by R. Robson. All in favor.

### **CORRESPONDENCE:** Robert Reitmeyer

- Notification from South Jersey RC & D requesting support of the South Jersey Tour des Farms that is being held on September 7<sup>th</sup>, 2019. On a motion of approval for Burlington County Soil Conservation District to give a donation of \$200.00 to support the event by A. Winzinger and seconded by R. Robson. All in favor.
- Firman E. Bear is hosting their Spring meeting on June 14, 2019 at the Pinelands Nursery and the topic of discussion is "The Amazing World of Dragonflies, Pollinators and Pollination Strategies."

# STAFF REPORT: Timothy Robinson

- T. Robinson, along with P. Saunders represented the District at the JB-MDL Earth Day on April 27, 2019. Saunders and Robinson set up a table with information for the residents on base. Robinson and Saunders distributed seed packets and other district items to interested attendees
- The NJ Envirothon was on May 10, 2019 and it was very successful. It was held at Great Times Day Camp in Waterford Works, NJ. The winner at the Envirothon was Mates (Marine Academy of Technology and Environmental of Stafford Township) and the second place was West Windsor of Princeton Junction, NJ.
- Poster Contest Winners: We have Certificates printed and checks have been processed. There were 4 winners. Suggestion from D. Caldwell is the district could have a large check and Robinson should get in contact with a Freeholder to take a picture with the 4 winners.
- T. Robinson has developed an electronic Compliance Inspection Request Form and has placed it on the district's website.

# NRCS REPORT: Nicole Ciccaglione

- N. Ciccaglione has provided the district with an updated listing of programs and status for Open AMA Contracts, Open EQIP Contracts, Conservation Stewardship Program and Open RCPP-EQIP Contracts as well as State Cost Share.
- 4 Plans for Signature for EQIP Contracts: Manure Storage Facility, Pivot in a greenhouse, Agrichemical Handling Facility and windbreak
- 1 Request for Assistance for a conservation plan
- One application cancelled in Monmouth County so we will go further down the list in central jersey. This will allow us to offer money to 4 more contracts in Burlington County.
- FOR EQIP 2019, NRCS currently has \$48,500.00 obligated and \$267,000 left to obligate by June 1, 2019. There is \$381,000 in new contracts in this office in total.

SSCC REPORT: No report.

### **DISTRICT MANAGER'S REPORT: Robert Reitmeyer**

**Snapshot off Activity:** For the month April 2019 the staff performed 324 inspections, issued ROC's for 169 Units and performed 31 plan reviews. Three Notices of Violations have been

issued since the April meeting. Violations were issued to **Prestige Learning Academy** of Mansfield for disturbance beyond approved limited, sediment barrier installation, offsite sedimentation; **2913 Route 130 South** of Delran for disturbance prior to approval and **Northline 6A** of Bordentown for required sediment barriers not installed or maintained and offsite sedimentation.

- Staff: Liz Wills will be leaving the District effective May 24, 2019. Reitmeyer will calculate the required compensation for unused leave time in accordance with the Policy Manual. We have already begun advertising to fill this vacancy.
- **Paul Evans** will be undergoing a surgical procedure on June 13, 2019 and is expected to be out at least 4 weeks to recover.
- Website Updates: T. Robinson has completed the necessary updates.
- **2018 NFWF Grant:** Planning is still underway for the grant. NRCS is currently reviewing detail analysis of the gypsum chemical composition from various providers for compliance with their specifications. Once accepted I will be able to move forward with producers.
- **2019 Municipal Shared Services:** Reitmeyer will be focusing on performing Basin Inspections.
- **Postage: P. Saunders** has contacted Stamps.com and she was provided with instructions on how to create an account and to begin using their method of postage metering. We will be returning the Pitney Bowes postage meter as soon as possible.
- Annual Work Plan: Reitmeyer will review and update the work plan.
- **SJRC&D:** Budget has been approved. Becoming active on the 319 Manalapan Lake Grant and another potential grant for basin restorations in Lakewood Twp. Ocean County is likely to happen. Planning for 2019 Tours des Farms is underway. The event is scheduled for September 7, 2019.
- NRCS CIG (Conservation Innovation Grant): The deadline for this grant is July 14, 2019. Reitmeyer will review the documentation and available staff time for drafting a submittal.
- **File Recertification:** This process creates income for District and also to keep the applicant in compliance with Chapter 251.

### CHAPTER 251 & RFA: R. Reitmeyer

Certification Report was presented and discussed. R. Reitmeyer reports there are **21 251** Plans and **6 RFA** permits that have been approved for this month. 251 Certifications mentioned for discussion are as follows: Larken Associates of Bordentown Township, Rancocas Glen Phase 1B, 2 & 3C Residential and Commercial of Mount Holly. On a motion of approval by T. Budd and seconded by D. Caldwell. D. Caldwell abstained from YMCA Camp Ockanickon; A. Winzinger abstained from Rancocas Glen Phase 1B, 2 & 3C Residential and Commercial projects in Mount Holly and Ward Sand & Materials Company in Woodland. All in favor.

- P. Saunders has compiled the necessary documentation and forwarded it to Frank Minch and the SSCC as required.
